Here are a few items that may interest you this month:

- 1. Update on Developmental Ministry. Same as last month: Tony Filipovitch, and the rest of our search team, have not yet received the name or name(s) of possible candidates. When a group of us were at the MidAmerica Regional Assembly last weekend, we were told that the Developmental Ministry congregations last year did not hear until June. So we practice patience!

At noon on Sunday May 21, 2017, the congregation of the Unitarian Universalist Fellowship of Mankato will convene to vote on two items:

## 1. Amendments to our By Laws

2. Approve the slate of candidate(s) for new board member(s), if needed. If the By Laws are approved, we will be reducing the number of at-large board members to 3, rather than 4, and then would not need to vote on a new at-large member.

Amendments to the By Laws:

Please review the bylaws by using the links here for the current bylaws and the amended bylaws.

Some of the changes include:

- 1. Changing the word 'fellowship' to congregation.
- 2. Using more gender-neutral pronouns.
- 3. Deleting the section on the minister: this belongs in the minister's contract.
- 4. Changing the number of at-large board members from 4 to 3.
- 5. Re-electing the Treasurer every 2 years, with no limits on consecutive terms.
- 6. Adjusted budget section to reflect the new timing of stewardship in the fall.

- Audit committee report
- Committee reports
- Minister's report
- Attitude of Gratitude

We hope to see a large group of members at our Annual Meeting this month. As it reminds us in Article IV, Section D of our By Laws:

"It is a privilege and responsibility of all members to participate in the Annual, Midyear and Special Membership Meetings of the Congregation. All members of the Congregation who have made an identifiable monetary pledge or significant service contribution within the current or immediately preceding fiscal year are eligible to vote at such meetings."
