Building Use Policy

Reviewed changes to the Building Use Policy which were requested by the Board during the last Board Meeting. The role of events coordinator has been changed to "Memorial Service Coordinator," to specify that our only role in coordinating events pertains to memorial services. Fees for building use were further defined and a difference was set for the fee scale paid by members and contributing friends compared to fee scale for nonmembers.

Discussion on Attitude of Gratitude Policy and Personnel Decision-Making Policy and Employee Handbook

A task force made up of Tony, John and Danielle has been formed to address changes to language in the Personnel Decision-Making Policy and Employee Handbook. Tricia and Diane will work on revising the Attitude of Gratitude policy before our next meeting.

Discussion of need to fill open At-Large Board Member position

Discussion of this decision centered on the positive aspects of inviting members with children in UUFM's CFD program and who have already shown interest in the operation of the church through volunteer activities they've already taken part in. Nancy will contact potential board members, with the list discussed.

Discussion of Hanska's request to share a minister

Hanska has asked if the UUFM would discuss the possibility of sharing a minister's time with them. The Board decided that this would not be an option at this time. We hear our congregation strongly support having a full-time minister living in our community.

Updates on: Minister search and search committee, choir director, janitor, Communication policy, File Retention policy, Minister's Emergency Fund policy

- We have one application from a candidate for minister and another who has shown interest and another seminary student who has interest but has obligations to fulfill before he would be available to be a ministerial candidate. Tony is arranging a telephone conference with Lisa Pressley to discuss our search process and offer insight or guidance.
- Our search for a choir director continues.
- Two people are working together to provide us with custodial service. They have signed a contract and have started providing services, scheduled to be done on Tuesday afternoons.

- John has begun talking with people who have experience with sound system set-up. The person John has contacted has experience in setting up a Hearing Loop system to provide better access to the church's sound system for people with hearing aids.
- Diane Dobitz and Barrie Evans met with Linda Ganske to discuss Linda's updates to the Communication policy. Linda will revise the policy to include changes that came out of that discussion and meet with Diane and Barrie again.
- Linda Ganske is working with the Finance Committee and other stakeholders to develop a File Retention policy.
