MOTION: Approve Consent Agenda. Tricia moves, Tony seconds. Motion approved.

# **Updates:**

- Tony notified us we currently have 11 candidates who've applied for minister. 5 of these were interviewed via Skype. From these 5, chosen candidates will move to the Neutral Pulpit step of the interview process.
- Tony asked for Board approval to appoint the Treasurer to the Search Committee to provide information to the committee when salary considerations need to be addressed.

**MOTION:** Appoint John Knox to the Search Committee to provide information to the committee when salary considerations need to be addressed. Tony F. moves; Andy R seconds . Motion is approved.

- File Retention policy and communication policy will be addressed in the next few months.
- Revised Attitude of Gratitude policy was discussed.

**MOTION:** Approve Attitude of Gratitude policy. Tricia moves, Tony seconds. Motion is approved.

Adding a Rental policy waiver to the Building Use policy was discussed.

**MOTION:** Approve Building Use policy with the rental policy waiver added. Diane moves, Tony seconds. Motion is approved.

• Diane asked for the Board to consider a request by a refugee group to hold a fundraiser at the UUFM. They are a group of Anuak people who have come here from East African

areas such as Ethiopia. Diane will contact the group and bring more information to the Board.

- Supervision of choir director: will be informal for the remainder of this church year, with Peter Kuhlman, choir director, using Nancy Cramblit as the contact person for any questions or concerns.
- We received recognition as a UUA Honor Congregation. Being able to call ourselves this has been seen as valuable by our ministerial candidates.
- We have been offered a chance to attend violent intruder training being offered by the Mankato Department of Public Safety. Linda Ganske, Carrie Rice and Tricia Nienow are likely attendees. It will be held 2-4:30 p.m. on Thursday, February 8, 2018.
- The text for a "Here We Believe" sign was shared and discussed.
- Amend the UUFM Committee Chair Job Description: Insert under **General Responsibilities**, as a third bullet in item 4:
  - Since the committee chair controls the committee budget, the chair must subscribe
    to the UUFM Conflict of Interest Policy and submit the required annual disclosure
    form to the Board Secretary.

**MOTION:** to update the Committee chair job description to include language defining how conflicts of interest will be recognized and handled. Tony moves, Andy seconds. Motion approved.

- Review of August retreat.
  - Chart on Circles of Involvement. The value and how best to convey the ideas in this chart to the congregation. Discussion centered on how the "Path to Identity" diagram gave retreat members a way to view how a church meets the needs of its congregation. The chart also offers definitions for how the involvement of its members maintains the church.
  - Work on a duty chart for minister and congregation. This may be best to address with the minister when he or she comes.
