So far we have received pledges of almost \$128,000 from about 2/3 of our members (60 households). There are still a few pledges outstanding which, if they all come in, will bring our total up to \$137,000—which was the goal we set for ourselves back in January before the Covid crisis hit. If you have not made your pledge yet, there is still time to get it in before the annual meeting.

Finally, the Board is planning to apply for a grant for technology and technical support to permit us to continue and to improve online streaming of our Services once we reopen our doors to regular meetings.
