# Reports

**Ministry**–Rita said that UUFM has reached the milestone of having the same minister for three years for the first time since 2011.

She said that the UUFM committee structure and the personnel within those committees are working well and in good order.

Rita has a draft covenant she is working on, it is located in DropBox.

Rita is doing more interfaith work than previously expected. A group of area spiritual leaders are writing two pieces regarding racial justice as a spiritual concern.

Rita listed additional meetings and retreats she is attending.

**Stewardship**—Tony presented the upcoming Stewardship Plan. The plan is for the timespan of 2020-2023. Bob made a motion, Cheiron second, to approve the Stewardship Plan. The vote was unanimous in favor. The motion passed.

Penny suggested and it was agreed that all board members write a letter of encouragement to fellow UUFM members regarding stewardship. We issued a board challenge that Stewardship Committee members do the same. Rita's spouse, Jeff Lowry was proposed as judge. Penny offered a prize for Best Letter. She will send challenge directions to members of both groups. All stewardship letters are to be sent to Tony by October 23, 2020. He will remove names and send letters to Jeff for judging.

**Communication**–Bob gave a report on the last communication meeting. Key messages include, "What messages do we want to get out?" as well as, "How is that message getting out?" The communications committee is writing a criteria for the Weekly Update. This will be available at the November board meeting.

Cheiron was asked to develop a criteria for a Facebook group that is dedicated to UUFM members.

Todd gave a review of Google Analytics reporting and its integration into the UUFM website.

# **Action Items**

Penny made a motion to request the Building & Grounds Committee identify a local boiler replacement consultant/ventilation contractor that is willing to inspect premises, and provide written recommendation & cost estimates for the UUFM building. The Building & Grounds committee will get this information to the board by November. John Knox second. Vote was unanimous in favor. The motion passed.

# **Discussion Items**

Should UUFM building remain closed through January 2021 and the indefinite future? The Board looks to Building and Grounds to provide us with an assessment of UUFM's ventilation and air handing system, likely timeline for needed safety enhancements and cost estimates, after which

the Board may discuss our need for a task force to develop re-opening protocols. John motioned to table further discussion of re-opening our building until the ventilation analysis is received. Kathryn second. Vote was unanimous in favor. The motion is tabled.

A review of the Board Response Portion of Minister's 2<sup>nd</sup> Year Renewal was held. The board reviewed and edited the document. Penny is processing the edits.

Bob motioned that we adjourn, John Knox second, unanimous in favor.
